We are delighted that you wish to become a member of Dunfermline Waterpolo Club.

The Club currently operates three mixed sex squads – Senior, Junior and Development. After our Coaching Team has assessed your abilities you will be placed in the most appropriate squad.

The Club's preferred method of communication is by email. Members who do not have access to email may request to have information posted to them. The Club's website is kept up to date and all members who have access to the Internet should check the website on a regular basis.

Membership fees for 2011 are as follows:

Senior, Junior and Development - £25

Associate Member - £10

Scottish Water Polo Annual Competition Fee - £15

Non-playing Member - £1

The current monthly fee for all squads is £18.00 payable by standing order and all playing members are liable for monthly fees in advance irrespective of attendance.

SASA registration fees for all "first claim" members are due in March. This should be paid to the club as soon as the new fees have been notified by Scottish Swimming. This is a mandatory requirement however **from 26 February 2011 the following will apply:**

There are two categories of members of Affiliated Clubs and a member may register in only one category. Those members who fall into both categories must register as a swimmer and pay the higher fee.

- a) Swimmer – a member of any age who participates in any aquatic discipline
- b) Non-Swimmer – a member who does not participate in any aquatic discipline as defined by the following classifications:
 - i) Club Volunteer - A member 14 years and over and not a competitor, who volunteers for their club in any capacity at any time.
 - ii) Club Volunteer Technical Official - A member who volunteers for their club and who holds a current technical official qualification issued by a recognised governing body for aquatics i.e. British Swimming or international equivalent.
 - iii) Teacher and Coach – A member who holds a current teaching or coaching qualification issued by a recognised governing body for aquatics i.e. SASA, ASA, WASA, British Swimming, an international equivalent, or S/NVQ in coaching.

CODE OF CONDUCT PARENT'S AND SPECTATORS

I agree to:

1. Consider the wellbeing and safety of players before the development of performance.
2. Always promote the positive aspects of the sport (eg fair play)
3. Encourage players to value the performance and not just results.
4. Do not ridicule or shout at a child for making mistakes or losing a game.
5. Never consume alcohol immediately before or during training or events.
6. Never condone rule violations or use of prohibited substances.
7. Display consistently high standards of behaviour and appearance, dressing suitably and not using inappropriate language at any time whilst involved in club activities.
8. Follow all guidelines laid down by the national governing body and the club.
9. Encourage and guide players to accept responsibility for their own performance and behaviour.
10. Always remember that the involvement in water polo is for the child NOT YOU!
11. Do not shout or abuse officials. Most officials give their time and effort for your players involvement.
12. Do not shout or abuse coaches or volunteer staff. They give their time and effort to help your players.
13. Support all efforts to remove verbal and physical abuse from sporting activities.

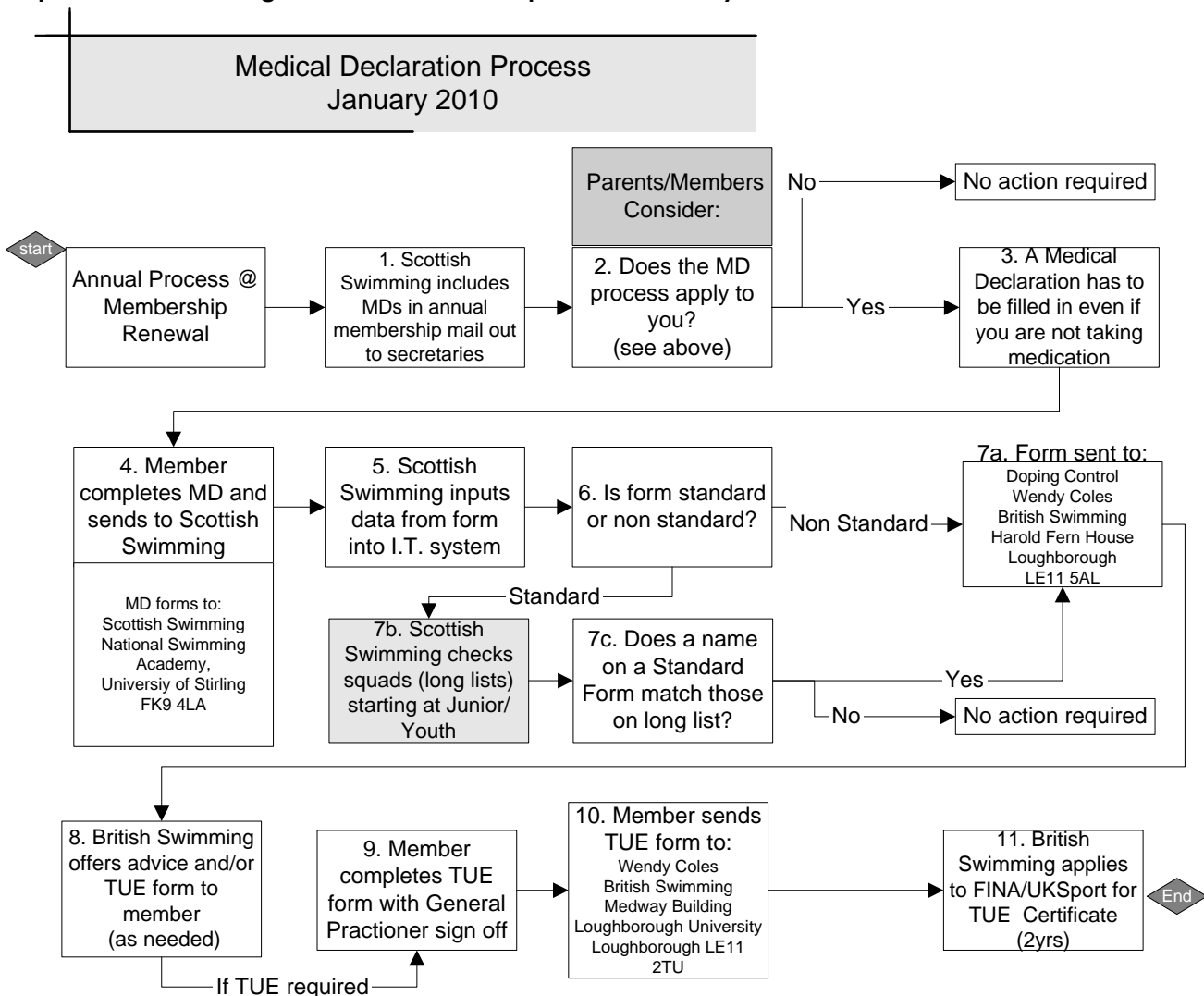
1. 9 years old (or younger), or
2. **Are not** competing in a British Swimming, Scottish Swimming, ASA or WASA National event
3. A master's swimmer who does not also compete in 'open events/ championships'

There are two forms that our members need to be aware of!

1. Medical Declaration forms (MD)
2. Therapeutic Use Exemption forms (TUE)

Scottish Swimming includes Medical Declarations with the annual Membership mail out.

The process for ensuring these forms are completed effectively is as follows²:



¹ Scottish Swimming will confidentially hold all information on these forms, with secure access provided to British Swimming Legal Department.

² British Swimming is the organisation responsible for doping control for Swimming in Britain.

MEDICAL DECLARATION FORM

This form **MUST** be completed by anyone that is representing Great Britain or their Home Country internationally or competing in a British Swimming, Scottish Swimming, ASA or WASA National event (all disciplines, excluding masters) and returned to the Scottish Swimming at the address below.

A new form **MUST** be completed annually even if the medication prescribed has not been altered or if no medication is being taken and whenever the medication is changed. If the competitor is under the age of 16 this form should be completed and returned by the parent or person in loco parentis but must still be signed by the competitor. This form should be sent direct to Scottish Swimming, not via the club secretary. The data contained in this form is classed as sensitive personal data under the Data Protection Act 1998 (DPA). Scottish Swimming, ASA or WASA will process the data provided in accordance with the DPA. Your express written consent to hold this data is required under the DPA, which by signing this form you are providing. The data will be held securely in accordance with the DPA and will be used to administer you as a member of Scottish Swimming, ASA or WASA. Information sheet ref. MedicalDeclarationProcess_WorkingDoc will assist in completing this form.
